

# SOUND EQUIPMENT AND SERVICES CONTRACT

## INTRODUCTION

This contract is made and entered into, by and between, John Senior Sound and \_\_\_\_\_ (the "CUSTOMER").

It is expressly understood and agreed that this contract is for the use of the sound equipment and services listed in the attached Sound Equipment and Services Proposal (the "PROPOSAL") on the day of \_\_\_\_\_, 2008.

The time required to unload and set up the required sound equipment, as deemed necessary by John Senior Sound, the time the sound equipment and services are to be used, and the time needed to tear down and reload the sound equipment, as deemed necessary by John Senior Sound, on the fore mentioned date will be hereafter referred to as "EVENT."

Any or all sound equipment provided by John Senior Sound during EVENT will be hereafter referred to as "SOUND EQUIPMENT."

## PAYMENT TERMS

Upon execution of this contract, CUSTOMER agrees to pay John Senior Sound the amount equal to \_\_\_\_\_ of the total cost indicated in PROPOSAL. The remaining balance to be paid by CUSTOMER at a prearranged time prior to EVENT.

## PERIOD OF AGREEMENT

This contract will commence upon the signing of this contract, and terminates upon completion of EVENT.

## CANCELATION / DEPOSIT

The deposit is the amount of money that is required by John Senior Sound to hold the date or dates on our calendar. In the event of a needed cancelation, John Senior Sound won't refund any deposit unless previously arranged 90 days prior to the event.

## MISUSE OF EQUIPMENT

In the event SOUND EQUIPMENT is stolen or damaged by a party other than John Senior Sound during EVENT, CUSTOMER is responsible for the full purchase cost of equivalent new equipment, to be paid within 30 days of EVENT.

## RIGHT TO TERMINATE

John Senior Sound has the total and complete right to terminate EVENT early during EVENT in case of poor weather or any other circumstance, per the judgment of John Senior Sound, that may put the safety of others and/or SOUND EQUIPMENT at risk. Upon termination, John Senior Sound will provide a refund of the amount equal to half of the total cost indicated in PROPOSAL.

## INDEMNITY

CUSTOMER agrees to not hold John Senior Sound responsible for any damages to property or personnel, from use or misuse of SOUND EQUIPMENT. CUSTOMER agrees to comply with all laws, regulations, and ordinances, as they exist at the time of EVENT, relating to the operation and use of SOUND EQUIPMENT.
